The Florida Department of Transportation (FDOT), District Four, will conduct a Public Hearing regarding the Project Development and Environment (PD&E) Study of SR 9/1-95 at PGA Boulevard/Central Boulevard, in Palm Beach County, Florida. **The Public Hearing will be held on Wednesday, September 28, 2016, starting with an open house at 5:30 p.m., at the City of Palm Beach Gardens Council Chambers, 10500 North Military Trail, Palm Beach Gardens, Florida 33410. The Public Hearing is being conducted to give interested persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effect of the proposed improvements.

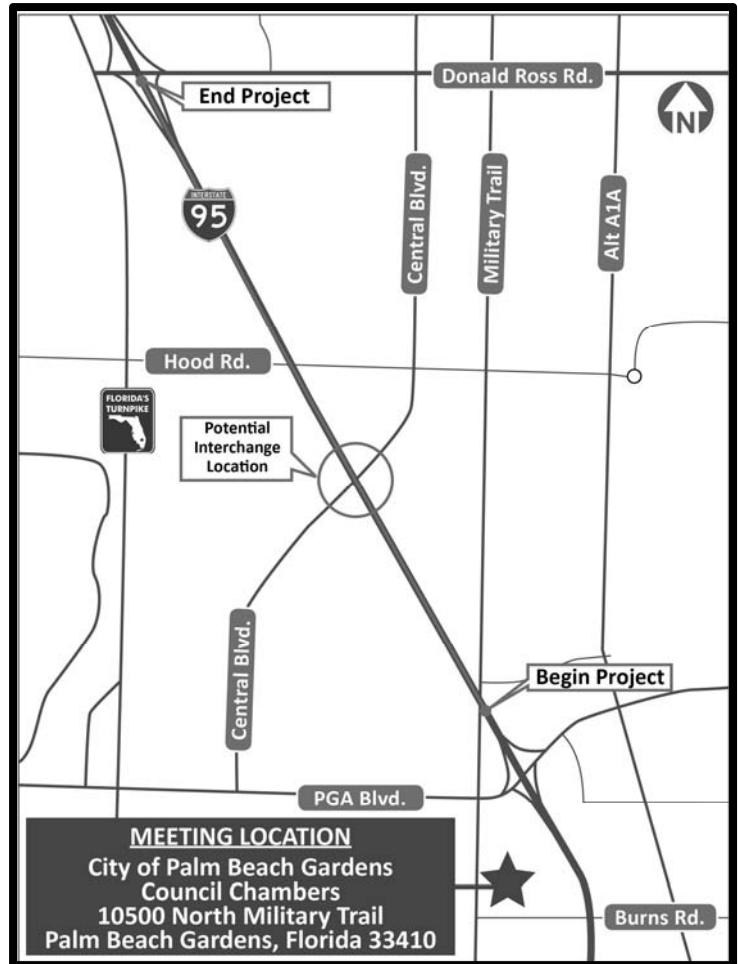
